## Summary of role

The role of the General Builder is to complete refurbishments and project work to various parts to the School also providing general site maintenance across the School. Working independently or as part of a team to help achieve the overall aims of the School.

Our maintenance work is a mix of planned and unplanned work, and we sometimes have to change what we are doing at short notice, to respond to weather related issues for example, to make sure that the School is able to continue to teach and support our children.
